Competition Period	Registration for the Competition is open from Tuesday 4 November at 9:00am and closes on Thursday 13 November at 5:00pm.
Entry Method	A South Australian Premier Cricket Club may nominate and select three (3) registered Club players to participate in the Competition and compete in a designated relay event for and on behalf of the relevant Club. To do so, Clubs must complete a registration form via https://forms.office.com/r/4Ns9zgK3VB . All participating Club players must have voluntarily agreed to participate, including having agreed to these terms and conditions.
	Clubs selected to participate in the Competition will be notified by a SACA representative no less than seven (7) days from the relevant match at which the Club's nominated team / representatives will compete.
	Selected Clubs' nominated teams must compete in relevant notified relay stages and rounds as set out in the section below addressing 'Selection and notification of winners'.
Maximum Number of Entries	One entry per South Australian Premier Cricket Club.
Total prize pool	Cash prize of \$5,000.00 for the winning South Australian Premier Cricket Club (with the prize to be granted to and for the benefit of the Club and not individual entrants and participants).

Selection and notification of winners	The winning Club will be the Club whose relay team:
	 is selected to compete in the Competition (per the Entry Method); successfully completes the notified required relay stages in the fastest time and prior to the opposing competing relay team(s) in any relevant preliminary rounds of the Competition, to be conducted on 14, 25 and 28 November 2025; successfully progresses though the preliminary round(s) to qualify for the 'final' to be conducted on 5 December 2025; and competes in the 'final' relay round conducted on 5 December and is judged to be the fastest team (finishing ahead of any other competing team(s)) in the 'final' relay. The winning Club will be notified immediately by SACA staff at the match on completion of the final relay round on 5 December 2025. The prize and winning Club's details (including names of the successful team participants) will be published or

Prize delivery	The winning Club will be issued their prize money via EFT from People First Bank.
	If the winning Club is unable or unwilling to accept and claim and participate in the prize as stated, or has not claimed the prize by the confirmation date specified above, the winner will be deemed ineligible and will forfeit the prize.
	The prize cannot be exchanged or substituted. The prize is not transferable.

Conditions of Entry
